The proceeding of the meeting started with recitation of the Holy Quran.

Mr. Akhtar Ali Khan Vice Chairman invited Mr. Saleem Ullah Khan Ranazai, Mr. Syed Amjad Shah, Mr. Muhammad Naeem Ud Din Khan, Mr. Atta Ullah Khan Tangi, Main Faheem Akbar and Mr. Ahmad Farooq Khattak to highlight the points for discussion by the participants on *“FREQUENTS STRIKES AND EFFECTS ON ALL THE STACK HOLDER INCLUDING LAWYERS, JUDGES, LITIGANTS AND THE GENERAL PUBLIC”*.

The meeting resumed after the tea break, the following Hon’ble participated Haider Ali Khan DBA Mardan, Ghulam Hussain Khan Takht Bahi, Malik Danyal Khan Swabi, Fazal Wadood Khan Bannu, Muhammad Tahir Khan Kohat, Muhammad Rasheed Khan Dir Upper,

Niaz Muhammad Khan Wari Dir Upper, Shad Muhammad Khan HCBA Abbottabad, Fazal Ghafoor Khan HCBA Darul Qaza Swat, Ayaz Khan GS PHCBA Peshawar forwarded their views, concerns and recommendation for a collective unanimous resolution on the subject meeting.

The house unanimously resolved the following resolution in the larger interest of all the stack holders and showed their firm determination for its implementation in latter and sprit.

RESOLUTION:-

1. The calls for any kind of Strike can only be given by Pakistan Bar Council under the Legal Practitioners and Bar Councils Act on a subject which is of National interest and issue that effects the larger strength of lawyers in the country.
2. The KP Bar Council can also give strike calls on a matter which is affecting the interest of the Legal fraternity in the province.
3. Where incidents like murder of a lawyer, physical attempt where the lawyer sustain injury, kidnapping, abduction, terrorism including bomb blast suicide attempts and related matters with in the province, the strike call can be given by the KP Bar Council.
4. In matters related to High Court Bar Association, District/Tehsil/Sub divisional Bar Associations the Presidents in consultation with the local members of KP Bar Council may give a call for token strike within respective district, like wearing black shoulder bands or not appearing before the courts after 12noon and with immediate intimation to the Secretary KP Bar Council.
5. In case all the Bar Council members from the zone agree to give a call according to its importance and gravity of the incident they can by majority give a call with in their respective zone, which will not apply to other zones of the province of KP.

6. In the light of above no full day strike will be announced by the respective President of the district bars as well as members of the Bar Council of the concerned zones, except the same announced by the Pakistan Bar Council or KP Bar Council.
7. The KP Bar Council will only give a full day strike call in the respective zones with reference to the above mentioned incidents after consultations with the respective Bar Council members of the zone.
8. The KP Bar Council will only give full day strike call, if the call is supported by majority members of Bar Council, but not less than 20 members.

DECISION OF THE HOUSE:

IN FUTURE ALL STRIKE CALLS ETC SHALL BE ANNOUNCED IN THE KHYBER PAKHTUNKHWA PROVINCE AS PER THE ABOVE RESOLUTION WHICH IS UNANIMOUSLY PASSED BY THE HOUSE. THIS WILL TAKE EFFECT IMMEDIATELY FOR ALL FUTURE PURPOSES FROM TODAY.
